IT WAS SUBSEQUENTLY DETERMINED THAT \$17,528 OF DONATIONS THAT WERE TRANSFERRED TO THE JOHN DAU FOUNDATION HAD BEEN RESTRICTED BY DONORS FOR THE PROMOTION OF EDUCATION IN SOUTHERN SUDAN. THESE FUNDS WERE TRANSFERRED BY JOHN DAU FOUNDATION TO A SEPARATE TAX-EXEMPT ENTITY TO ENSURE THAT THE FUNDS WERE EXPENDED FOR THE INTENDED USE.
